- 12. This contract constitutes the entire agreement between the parties here on and there are no understanding, oral, written, relating to the subject matter hereof. This agreement may not be changed, mentioned or amended, in whole or in part, except in writing and signed.
- 13. Exhibitors found in violation of any of the "Conditions of the Show" may be excluded from future Festivals, have their exhibits removed from the Festival and their deposit checks processed.
