### Conditions of the Show:

1. Deposit will be returned provided the "Conditions of the Show" are met.
2. Vendors **MUST** be open during the Festival hours (Thurs. –Sat. 11:00AM to 8:00PM; Sun. 11:00AM to 6:00PM) on the day(s) selected.
3. An application is a commitment to show. Vendors are committing to be present as indicated above. Vendors that cancel their appearance once accepted, do not show up, or leave early forfeit their deposit and may not be invited back.
4. All Committee decisions regarding space assignments are final. Once assigned a space, vendors are not permitted to set up elsewhere.
5. All vendors will be issued one vehicle parking pass which must be displayed on your vehicle.
6. All signage must be in good taste and not in conflict with the spirit of the Festival.
7. Vendors may not bring pets to the Festival.
8. Set-up must be completed by 10:00AM each day. No vehicles will be permitted to enter the Park after 10:00AM and all vehicles must be out at this time. Vehicles may re-enter the Park each day after the close of the Festival, not before, no exceptions!
9. Only works by the author (in whole or in part) listed on this application may be offered for sale. Acceptable works include books, magazines, pamphlets, DVD's, or audio recordings. Only authors are permitted to sell items. Other merchandise may be sold with prior approval. Items that were not approved will be removed. Authors that exhibit in the Festival are asked to donate books to the Festival for fundraising purposes in exchange for their booth.
10. This contract constitutes the entire agreement between the parties here on and there are no understanding, oral, written, relating to the subject matter hereof. This agreement may not be changed, mentioned or amended, in whole or in part, except in writing and signed.
11. Exhibitors found in violation of any of the "Conditions of the Show" may be excluded from future Festivals, have their exhibits removed from the Festival and their deposit checks processed.

### RELEASE and ACCEPTANCE

**General Release and Acceptance of Rules** - This contract is for the Westmoreland Arts & Heritage Festival (WAHF) to which the vendor applies or is accepted.
